

Flying Deer Nature Center Payment Plan Agreement Fall 2011

The Payment Plan option is available only for semester or year-long programs. The maximum number of payments is four. An additional \$20 is added to the tuition amount to cover the processing of payment plans.

Payment Plan installments are as follows: 40% of the program tuition for the first payment and 20% for the three subsequent payments. You will receive an invoice when payment is due. Payment plans may be established for shorter programs in the rare case of a family crisis, and those payment plans will require payment in equal installments over a period not to exceed six months.
